### THE CONDITIONS OF THIS SALE ARE AS FOLLOWS:

The kitten described above is being sold as a female show/breeder with the following consideration: Purchaser accepts the responsibility of caring for the kitten and providing properly for its welfare.

This includes:

- (a) Keeping the kitten/cat in a clean and pleasant environment
- (b) Giving the kitten/cat proper nutrition as advised on care sheet
- (c) Providing all necessary veterinary care to this kitten to maintain its good health
- (d) Providing it with love and companionship.
- (e) \*\*\*\*(UK HOMES ONLY)\*\*\*\*\* **Your kitten comes with 5 weeks insurance that covers the vets fees and the value of your kitten (UK homes only). It is strongly recommended you continue with the free five weeks insurance to cover any unforeseen medical problems. We cannot be responsible for vets bills. When you continue the insurance do take cover that also includes your kittens value. We recommend that you continue with Agria for the first year to ensure continuity of cover. Should you wish to change insurers, please overlap the policy by 2 weeks as new insurance does not cover for the first 2 weeks. Buyer accepts full responsibility for continuing insurance. You will note that you also get insurance through the microchip with Pet id, this does not cover any value for your kitten so please ignore this insurance be advised to continue through Agria.**
- (f) Any health or settling in concerns to be discussed solely with either the vet or the breeder. Not for public discussion.
- (g) The full balance for the kitten must be paid for by the time she reaches 3 months of age (unless otherwise agreed). Should the balance not be paid, we reserve the right to keep the deposit and re-advertise the kitten.

There are no guarantees given on show achievements of kittens/cats sold with show rights. The kitten/cat is sold with the understanding that it is free of any disqualifiable faults at the time of sale. Seller will not be responsible for faults that can show up at a later date.

The Seller guarantees fertility in this breeding animal. If this cat has not produced viable offspring by the age of 2 years after being bred to at least two (or three) proven studs, Seller agrees to replace the kitten/cat with a kitten/cat of comparable quality and value when one is available at pet price. Proof of spay/neuter by a licensed Veterinarian is required. Seller will not replace a kitten/cat for birthing problems, pyometra or caesarian section.

Any cat which is spayed without our consent will not be entitled to any compensation

With regards to HCM, should the kitten be diagnosed with it positively prior to having kittens, then we will replace her with a cat or kitten of our choice of comparable quality when available. No cash refunds will be given for any reason.

Under no circumstances will this cat or its prodigy be leased, given away, or sold to any pet shop, research laboratory or similar facility.

**If for any reason you do not wish/cant continue with your breeding programme, your female kitten/cat MUST be spayed before re-homing. She is not to be sold on for breeding. If this condition is ignored there is a £2500 penalty to be paid.**

**Health Guarantee:**

My kittens come having had vaccinations at 9 and 12 weeks of age for flu, enteritis. They have been wormed regularly, are litter trained and have 5 weeks free insurance (UK homes only). The kitten has been examined by our veterinary surgery at least twice prior to sale with no health issues.

If the kitten/cat should die due to congenital defect (may not be apparent in early life) within the first 12 months it will be replaced with a kitten of comparable quality and value when available. A post mortem is required to verify the cause of death.

If there are any proven congenital defects with the cat/kitten after 12 months then please consult us and we will discuss things and try to help/advise you. However, once the kitten/cat has produced live kittens, that have been sold, gifted, traded (swapped) or kept for the breeders breeding program, there will be no replacements of any kind should an unforeseen health issue arise with the said kitten/cat.

Each kitten/cat will differ in the time needed to bond with its new family. Please give the kitten/cat ample time to adjust, especially if the kitten/cat has been shipped. A period of two to four weeks should be the very least amount of time allowed the kitten/cat for an adjustment period and longer if this is an adult cat or there are children in the house. Please give your new friend and family member a chance to bond with you and its new surroundings. Your new cat/kitten needs to feel safe and secure for its unique individual personality to surface.

UNDESIRABLE BEHAVIOUR ISSUES (spraying, inappropriate urination, scratching of furniture etc) developing once the kitten/s has been turned over to the purchaser and conditions such as colds, virus, bacterial infections and skin rashes are not conditions for return or refund. The vendor will happily work with the purchaser to modify any behavioural issues.
