**RE: REPLY TO SHERIFF GORE
HIS RESPONSE TO MY COMPLAINT AGAINST
THE COUNTY COVID-19 LOCKDOWN**

Dear Sheriff Gore (et al),

This is my reply to your May 11, 2020 public announcement titled, "*Sheriff Bill Gore Statement on Enforcement of Public Health Orders*",¹ which appears to be a direct and indirect response to my Covid-19 lockdown complaint letter to you, Health Officer Wooten, Gov. Newsom and others, sent to you by email and mail on May 9, 2020.²

While I would assume that you are an honest man, a loving husband and father, who cares for his family, his community and his country, with a family history of law enforcement, I do not agree with your point of view, in that you are in law enforcement and you simply must obey orders and have no responsibilities beyond that. That is not the attitude of an honest man, but of a puppet with no conscience, a coward, a traitor to his Oath of Office, or an enemy of the people and a willing Criminal Participant, as will be described below. Your response and actions after reading this reply will tell us what category you fall under.

Your quote from Sir Robert Peel was misused and was inappropriate for your response. What the quote says, in a nutshell, is that it is better to have citizens that comply with orders and legislation voluntarily to avoid conflict with law enforcement; but what it means is, if no voluntary compliance, then it will have to be compulsory, under threat of coercion, physical force, arrest, fine and imprisonment.³ What the quote does not address is the whole basis of my complaint, the fact that the state and county orders on the lockdown are unconstitutional, and therefore, are null and void, unenforceable and cannot be law.

No, Sheriff Gore, the much more appropriate quote in our present circumstances is from Dr. Martin Luther King, Jr., when he said,

"ONE HAS A MORAL RESPONSIBILITY TO DISOBEY UNJUST LAWS"

Or as Albert Einstein said,

***"THE WORLD WILL NOT BE DESTROYED BY THOSE WHO DO EVIL
BUT BY THOSE WHO WATCH THEM WITHOUT DOING ANYTHING."***

My complaint provides enough data to prove that this lockdown is unnecessary and harmful to our community members and economy. A recent interview of world-renowned molecular genetics and immunology expert Prof. Dr. Dolores Cahill confirms every point I make in my complaint.⁴ The issue of the dangers of having healthy and sick people wear filtering masks or facial coverings is also well documented, as world-renowned scientist Dr. Russell Blaylock points out in a May 11, 2012 article, where he writes:

*“As for the scientific support for the use of face mask, a recent careful examination of the literature, in which **17 of the best studies were analyzed, concluded that, none of the studies established a conclusive relationship between mask/respirator use and protection against influenza infection ... Several studies have indeed found significant problems with wearing such a mask. This can vary from headaches, to increased airway resistance, carbon dioxide accumulation, to hypoxia, all the way to serious life-threatening complications ...***

*While most agree that the N95 mask can cause significant hypoxia and hypercapnia, another study of surgical masks found **significant reductions in blood oxygen as well.** In this study, researchers examined the blood oxygen levels in 53 surgeons using an oximeter. They measured blood oxygenation before surgery as well as at the end of surgeries. The researchers found that the mask reduced the blood oxygen levels (paO2) significantly. **The longer the duration of wearing the mask, the greater the fall in blood oxygen levels ...***

Studies have shown that hypoxia can inhibit the type of main immune cells used to fight viral infections called the CD4+ T-lymphocyte. This occurs because the hypoxia increases the level of a compound called hypoxia inducible factor-1 (HIF-1), which inhibits T-lymphocytes and stimulates a powerful immune inhibitor cell called the Tregs. This sets the stage for contracting any infection, including COVID-19 and making the consequences of that infection much graver. In essence, your mask may very well put you at an INCREASED RISK OF INFECTIONS and if so, HAVING A MUCH WORSE OUTCOME”.⁵

Even Dr. Anthony Fauci, who is spearheading this campaign for compulsory lockdown of our economy, social distancing and house arrest for our whole population, has put it bluntly in an interview, when he said,

*“People should not be walking around with masks ... there is no reason ... and often, there are unintended consequences ... When you think masks, you should think of **healthcare providers** needing them **AND PEOPLE WHO ARE ILL**”.*⁶

In my complaint against the State and San Diego County orders (sic), hereinafter health orders, I provide proof that the actions being taken by government officials will not help the members of our communities, but to the contrary, are detrimental to our residents' health. This is nothing less than a quarantine, but for the first time, of healthy individuals. Just like when in a corrupt justice system, a

person is considered guilty until proven innocent, the health orders classify all residents as Covid-19 infected and carriers until proven virus free.

In a recent press conference Chula Vista Mayor Mary Salas said that she did not want to take Draconian measures, like levying fines and jailing persons for disobeying the Covid-10 health orders but said she would. Her statement confirms that such actions are excessively harsh and severe, unwarranted, and therefore unconstitutional.

The fact that you have issued only two citations out of the 330 complaints you have received about people violating the health orders is nothing to boast about. Those two citations should have never been issued, and in the case of the other 328 complaints, if you investigated them, your department most likely directly or indirectly threatened those investigated with subtle or strong statements of the consequences if they did not comply, all intended to instill fear of violating the unlawful lockdown order.

Neither me nor millions of Californians are on lockdown with our lives upside down “voluntarily”, so there is no voluntary compliance, but coercive compliance. In fact, this mass lockdown is a direct violation of the 8th Amendment of the U.S. Constitutions, which states that *“Excessive bail shall not be required, nor excessive fines imposed, **NOR CRUEL AND UNUSUAL PUNISHMENTS INFLICTED.**”* What can be crueler than being forced to stay home, to not go where we wish, to not gather with family and friends, not to have any social interactions, and being forced to wear a mask whenever we are outside? **We are in an undeclared de facto Martial Law that has us imprisoned at home without due process of law, even though most of us are healthy and pose no threat to anyone.**

You are correct Sheriff, in that there are three branches of government and that only a court can declare what the law is, which means a court can declare any order unconstitutional, null and void and thus unenforceable, so it would have never been actual law prior to that. Your comment that you want to stay on the law enforcement side, the executive side, to simply follow department and superior’s orders is misguided. What you fail to note is that you took an Oath of Office to uphold the U.S. Constitution, and that includes making sure our State’s resident’s constitutional rights are not violated.

In other words, you are trying to use a Nuremberg defense to justify why your department is telling people that they can’t go out as they wish, whether to beaches, parks, to gather in groups, to worship in congregations, or to open their businesses against the lockdown order. Some of the people that used the *“I only took orders”* defense got hanged, as it did not justify their actions. The Nuremberg trials tell us that that individual rights to life, freedom and happiness are black and white, and that such rights don’t come from constitutions and the government officials that write them, but that our rights come from God, a superior authority than yours or the state’s. There is no need for you to wait for a court to tell you whether this lockdown is lawful, because it is not, it clearly violates our rights of association, to freedom of expression, to ask for government redress, to express and practice our religion. We are all innocent until proven guilty, and most of us are healthy and pose no threat to our communities.

The Wisconsin Supreme Court agrees that this lockdown is unconstitutional.⁷ As I mentioned in my complaint, other police officers and sheriffs around the country are not enforcing similar lockdown orders, such as Fresno Sheriff Margaret Mims.⁸ The city of Atwater, CA, declared itself a 'sanctuary city' for business, allowing businesses to open and people to go out. As Mayor Paul Creighton stated,

"This is America. You have the choice. It's time for the government to stop dictating another month, another three months, six months ... When is it going to end? When everyone is bankrupt?"

From a legal and technical standpoint, Gov. Newsom's executive order, based on a supposed "state of emergency", has no foundation in law, in that Newsom is basing his order under the argument that we are in a Covid-19 epidemic. An "epidemic" affects a disproportionately large number of individuals within a population at the same time. While highly transmissible, Covid-19 has been estimated to have affected only 4%-5% of CA's population; the Santa Clara antibody study estimated 2.8% in that county. The 74,900 documented 'cases' represent 0.18% of the population, and the 3032 or so who have died represents 0.0007%, to date; well over 99% of the population will NOT die. CA has a viral outbreak, not an epidemic.

Also, California's "state of emergency" should have terminated on May 3rd, 60 days after Executive Order N-33-20 was issued (ref. CA Govt Code §8558(b) and §8627.5(b)). Governor Newsom has extended it without legal basis.

From a medical standpoint, Dr. Anthony Fauci clearly stated in his editorial comments in *The New England Journal of Medicine*, dated February 28, 2020, and titled "Covid-19 — Navigating the Uncharted", that Covid-19 would most likely result in nothing more than a severe influenza season. He notes:

*"This suggests that **the overall clinical consequences of Covid-19 may ultimately be more akin to those of a severe seasonal influenza** (which has a case fatality rate of approximately 0.1%) or a pandemic influenza (similar to those in 1957 and 1968) rather than a disease similar to SARS or MERS, which have had case fatality rates of 9 to 10% and 36%, respectively".⁹*

To maintain this lie about exaggerated numbers of deaths related to Covid-19, as opposed to other serious underlying conditions that would have resulted in death anyway, health authorities and the media point to overwhelmed hospitals with Covid-19 victims, daily news shows showing videos of long lines outside these hospitals, but multiple videos shortly thereafter of all those hospitals that claimed such chaos show that there are no such long waiting lines. As soon as these videos appear in Facebook and YouTube, they were immediately removed or banned, but are still available.¹⁰ The most outrageous example of the Covid-19 victims farce is a video of a man getting into an enclosed gurney in an ambulance to appear to be a victim. See full video in footnote below.¹¹



The San Diego Union featured an article on or around April 1, 2020, noting how our local hospitals were overwhelmed with seriously injured Covid-19 patients and featured a photograph of Sharp Coronado Hospital, noting that tents had to be setup outside to deal with the large crowds, so I went there a couple of days later around noon and saw such tents at the main entrance. The tents were empty, only 2-3 hospital staff with masks on, no one in line or being cared for. Then I was approached by a nurse

who asked if I needed help. I asked how many persons they had in the hospital with Covid-19. After trying to evade my question, the nurse finally said, “no one right now.” Here are the pictures.



Then I called our local 211 Helpline and asked in which hospitals we had all the claimed critically ill Covid-19 patients and was told that in ALL our local hospitals, but when I mentioned what I had just been told by the Sharp Coronado nurse, the attendant hanged up on me. So, I called the San Diego County Health Department requesting the names of the hospitals where all the Covid-19 victims were and was told they could not provide me such information.

Mainstream media has been working hard to mislead our country as to the reality of the Covid-19 emergencies. Two classical examples are CBS news showing a video of a busy New York emergency room, when in fact the video was shot earlier in Italy,¹² and the more recent one where CBS arranged a filming of patient testing lines using hospital personnel.¹³

According to our County Health Department, by May 14, 2020, we had 194 Covid-19-related deaths, but as San Diego County Supervisor Jim Desmond explained recently, there were only 6 “pure” Covid-19 actual deaths, the rest had underlying health conditions that resulted in their death.¹⁴ This is not a pandemic or epidemic emergency, this is purposeful fraud by health authorities following the guidelines of the CDC, Dr. Fauci and Dr. Deborah Birx¹⁵ for reasons that will be explained below.

The truth is that, based on directives by the CDC and the National Vital Statistics System (NVSS), through their *Vital Statistics Reporting Guidance* document,¹⁶ all cases of death, confirmed “or suspected”, are to be coded and declared to be Covid-19 related as the primary cause of death. The Guidance document states,

*“In cases where a definite diagnosis of COVID–19 cannot be made, but it is **suspected or likely** (e.g., the circumstances are compelling **within a reasonable degree of certainty**), **it is acceptable to report COVID–19 on a death certificate as “PROBABLE” or “PRESUMED.”**”*

The same type of fraud was used to inflate the H1N1 “pandemic” fatality numbers back in 2009-2010. This was clearly uncovered and reported by Sharyl Attkisson of CBS news, in her article titled, “Swine Flu Cases Overestimated?”.¹⁷

According to the San Diego County Covid-19 order, the primary reason behind the order is that county health officials want to “*preserve critical and limited healthcare capacity in the county and will save lives*”,¹⁸ but our healthcare capacity is more than capable of taking on any surge in Covid-19 victims, which has not occurred, as noted above.

San Diego has 5,662 confirmed cases of Covid-19, but that does not mean that they are all hospitalized or in bad health. Further, since last year in the USA around 60 million people were exposed to the flu and since health authorities say that most people won’t even know they had or have Covid-19, with no symptoms, the confirmed cases are minimal. The 2018-2019 influenza season had 9,373 cases of the flu, 69 flu deaths, and 27 outbreaks.

Governor Newsom’s guidelines to reopen the economy and allow people outside their home are impossible to comply with. First, because everything is being coded as Covid-19, tests are in many cases not done or only done for Covid-19 and not the flu, which is still in our community, and tests being performed are not conclusive that in fact it is Covid-19 when a positive test is shown.

The CDC admit tests are not 100% conclusive. In the CDC report “*CDC 2019-Novel Coronavirus (2019-nCoV) Real-Time RT-PCR Diagnostic Panel*”, pages 2 and 37, it states,

“Positive results are indicative of active infection with 2019-nCoV but do not rule out bacterial infection or co-infection with other viruses ... This test cannot rule out diseases caused by other bacterial or viral pathogens”.¹⁹

As to Covid-19 infecting surfaces for a long time, the CDC now came out with an announcement that in fact, Covid-19 cannot spread that easily through surface contact, it being like the flu virus.²⁰

Remember all the governors saying they would have thousands of deaths, New York asking for 40,000 ventilators and ending up needing less than 400 and U.S. Navy hospital ships on both coast waiting for patients that never came, tents for thousands taken down because they were not used? This brings the number down from the predicted 2.2 million Covid-19 deaths to less than 100,000, and by the evidence I provide here, that number is highly suspect.

But maybe more important in all of this is to understand that, as noted by our health authorities, any emergency as the one declared for Covid-19 in our state and county is based on our “supposed” lack of ability to stop this disease and the illness and deaths associated with it. We are told that only a vaccine will save us in order to return to our way of life. This is the ultimate lie, as there is at least one cure.

As President Trump told us from the start, a proven cure for Covid-19 has been found (among others). As he stated in his press conferences, hydroxychloroquine has proven to be an extremely inexpensive and readily available remedy for this disease. As recently noted by the New York Post, *“Hydroxychloroquine rated ‘most effective’ coronavirus treatment, poll of doctors finds”*.²¹

In New York, 9 out of 10 people placed on ventilators died, while a French chloroquine study of over 1,000 patients showed no need for ventilators, all patients recuperated within 9 days, and there were zero deaths.²² There is no need to wait for or use a vaccine. Covid-19 can be easily cured.

In a May 7, 2020 article in *The Lancet – Rheumatology*, it notes that Covid-19 isn’t an Acute Respiratory Disease (ARD). Rather, it often presents as an inflammation and blood clotting condition which causes the blood to be unable to carry oxygen, resulting in patient hypoxia and eventual asphyxiation. This explains why ventilators have been deadly to most patients, while hospitals are utterly failing to address the real root of the problem.²³ The World Health Organization (WHO), Dr. Fauci and other top health authorities where recommending that ventilators be used for patients Covid-19 as the proper standard of care.

In one of the initial presidential press briefings on Covid-19 and the president’s comments on chloroquine, Fauci said that the evidence the president was referring to was anecdotal, not based on facts or research, but that was a lie. Dr. Fauci’s and the National Institute of Health knew or should have known that the CDC knew since at least 2005 that chloroquine is effective against coronaviruses.²⁴ Our health department should be recommending chloroquine as a standard Covid-19 treatment protocol, not only on patient’s that are in their deathbeds, as New York Mayor Cuomo authorized. Some states even banned it. Chloroquine is so safe that it is used routinely for people traveling to Africa to avoid malaria. It is even recommended for pregnant women and is considered safe.²⁵

One would assume that Dr. Fauci and our health authorities would be welcoming any physician’s experience with successful Covid-19 treatments. For example, ozone therapy has been proven by various physicians in the US to be effective, as well as IV vitamin C therapies, which is also being used in China. Yet, here in the United States those innovative independent doctors are harassed, attacked, and their records seized by authorities.²⁶

Have you ever asked yourself, why the six feet distancing requirement? Where does that come from? According to the CDC, *“People with flu can spread it to others up to about 6 feet away. Most experts think that flu viruses spread mainly by droplets made when people with flu cough, sneeze or talk”*.²⁷ If Covid-19 is said to spread the same way, which means that all the tens of thousands of persons classified as having died of the flu in all previous years, which as I noted herein are similar to the Covid-19 deaths presently reported, then all those persons got infected by getting closer than 6 feet with those infected, or they could have touched a surface. Why have we not been asked before to stand six feet away and avoid all contact with anyone outside the household? The answer to that explains everything else that is happening with this alleged/sham global Covid-19 pandemic.

THE TRUTH ABOUT THE COVID-19 LOCKDOWN

Sheriff Gore, if you still have not figured it out what is really behind the lockdown, after all that is being exposed by the new media, in particular alternative news, then let me explain it to you in the simplest terms. This is all about mandatory vaccines on every child and adult in the planet. It is about increasing the \$60 billions a year market of childhood vaccines, with the hundreds of billions that can be made if vaccines are made mandatory worldwide for adults, starting with a mandatory Covid-19 vaccine, then all the vaccines in the CDC adult schedule.²⁸ Big Pharma has infiltrated our health agencies and have used these agency heads to approve untested and dangerous vaccines on the public.

How do I know? Because no vaccine in the childhood schedule has been tested against true saline placebos, the gold standard of safety testing, as Dr. Fauci was saying would be needed for chloroquine before he would endorse it. Instead of comparing a vaccine with a placebo, they compare them to other vaccines, then because both groups suffer injury, they claim that then the tested vaccine could have not had caused any injury.²⁹ As the reference table shows, these vaccines have also not been tested for fertility and carcinogenicity and most studies only last a few days or weeks.

In the only study done using a true placebo, one group of HPV/Gardasil vaccine subjects, the placebo group had zero injuries, but Merck combined that group with another group that received toxic aluminum to hide the result.³⁰ I prepared several flowcharts that prove that vaccines have not been proven safe and are most likely responsible for much of the chronic illnesses in our children and adults.³¹

While I believe President Trump is doing his best for our country in the handling of the Covid-19 crisis, his top medical adviser, Dr. Fauci, is highly compromised and has vested financial interest in the promotion and selling of vaccines, especially in having the government make them mandatory,³² with the added advantage that vaccines and anyone involved with them have zero liability based on a unjustified 1986 vaccine law and special court system that exists to protect the manufacturers. Dr. Fauci even has discouraged the use of chloroquine, and has promoted Remdesivir, claiming it to be +30% effective, a drug that costs thousands for a treatment, compared to chloroquine, which costs .10-.50 cents a table, and you only take 1-2 a day for 3 to 9 days.

Further, Dr. Fauci was involved in a clinical study of Remdesivir, and when positive safety results were not being achieved, he changed the number of participants several times, then he started removing the types of person that originally would be considered in the study, then he removed death as a reportable outcome, and now the study has been cancelled. These are the types of things that prove this mandatory lockdown is unnecessary and therefore a fraud.

Don't allow supposed health experts or fact checkers discourage you from seeing the evidence, like seeing Dr. Judy Mikovits interview in the documentary *"Plandemic"*, the movie *"Vaxxed: From Cover-Up to Catastrophe"*, which shows the CDC whistleblower admit that the MMR vaccine causes autism,³³ or the movie, *"Vexed Truth: The People's Truth"*, which shows all the injuries caused to adults and children by

vaccines, like the triplets that all went into an serious autistic state after being vaccinated the same day.³⁴ Since when has censoring become the best way to expose a lie?

In your many years in law enforcement you know that there are many criminal conspiracies taking place all the time. Adolph Hitler's criminal conspiracy, his plan of world domination, required thousands of willing participants. We are not dealing with a conspiracy theory, we are dealing with a ruthless criminal conspiracy against humanity. I expose this whole Big Pharma vaccine conspiracy in my Vaccine Class Action Complaint (VCA Complaint), filed with the U.S. Department of Justice and the U.S. Department of Health and Human Services, on July 2, 2017.³⁵ One of the persons named in my complaint as a Criminal Participant is San Diego County Health Officer Wilma Wooten.

This group of conspirators are already working on the mechanism to legally pass laws to make a Covid-19 vaccine mandatory. The person behind this is professor Dorit Reiss. Her recent writing in the Journal of Law and the Biosciences is titled, "*Considerations in Mandating a New Covid-19 Vaccine in the USA for Children and Adults*".³⁶ Mrs. Reiss is also named as a Criminal Participant in my VCA Complaint.

The WHO has played a big roll in both the spread of the Covid-19 worldwide and giving recommendations to address it that are contrary to the medical needs of the patients. As to Covid-19, the WHO mislead the world by not informing global health authorities about how contagious this disease was, initially saying it was not even contagious. This is the same organization that promoted globally and helped fuel the opioid crisis and who is heavily funded by Bill Gates, who is promoting mandatory vaccines on the world population and is working on and has patents for products related to vaccines, from the vaccines themselves, to tracking devices for vaccine compliance. Dr. Fauci has similar financial interest related to Gates.

The WHO's Health Emergency Director, Mike Ryan, recently said, "... *This virus may never go away ... We do have one great hope, if we do find a highly effective vaccine that we can distribute to everyone who needs it in the world, we may have a shot at eliminating this virus.*" He said, "*That vaccine will have to be available, it will have to be highly effective, it will have to be made available to everyone, **and we will have to use it.***" He continued, "***and people have got to want to take that vaccine***".³⁷

Many are profiting with what is happening, including medical hospitals and even pediatricians who get paid a bonus of \$400 for each patient when a certain percentage of his/her patients get all the recommended child vaccines,³⁸ and when a parents tells them their child just got injured by a vaccine, they will just say it is a coincidence, that it could be **anything other than the vaccine**, even though the vaccine inserts confirms all those possible injuries.³⁹ These pediatricians will also not report the vaccine injury in the VAERS system set up for that purpose, as required by law.⁴⁰

It is well known that in the case of persons infected annually with the flu, they can start spreading the disease two or more days prior to any symptoms and that such person can be contagious for five to seven days, if not longer. Such persons where never asked to quarantine for a week or two, nor did we close our businesses. Elderly persons with underlying conditions were just as vulnerable to such flu as they are to Covid-19.
