

**COMMENTS TO OCCUPATIONAL SAFETY AND HEALTH STANDARDS BOARD
REGARDING THEIR COVID-19 RULE READOPTION, JUNE 3, 2021**

The CDC estimates that the 2019–2020 flu season in the US had caused up to 56 million flu illnesses, 740,000 hospitalizations, and 62,000 deaths.¹ Cal-OSHA never took any action to prevent flu infections, hospitalizations, or deaths. And rightly so, as Cal-OSHA cannot stop the transmission of the flu, just like we have seen that the extreme restrictions of the local COVID health orders never stopped COVID transmission.

According to Wikipedia, so far there have been 33 million cases and 600,000 deaths associated with SARS-CoV-2, or COVID.² According to the CDC there have been 362,000 COVID hospitalizations.³

Therefore, we had almost twice the hospitalizations in the 8-month 2020 flu season than we have had for COVID in 15 months. The hospitalization vs. death ration in the case of flu was 11 to 1; but in the case of COVID it was 1 to 2, twice as many deaths as hospitalizations, which historically and medically makes no sense.

Before COVID, in a typical flu season in San Diego County we had 17,000 infections, but by December 2020 the San Diego Department of Health had only reported 36 cases of the flu.⁴ Somehow the COVID virus made the flu numbers almost disappear.

On August 2020 the CDC quietly updated its COVID death count from 153,000 to 9,000 actual COVID deaths because 94% of those in the previous death count included persons that had 2 to 3 pre-existing serious illnesses and the majority where of advanced age, therefore their death was not attributable to COVID.⁵ The correction brought down the original number to 6%. If we take the present COVID death number and reduce it to 6%, the number of actual COVID deaths would be 36,000 death, and not the claimed 600,000.

So it appears that Fauci and CDC's Dr. Robert Redfield where right as far back as March 2020 when they wrote in an article in The New England Journal of Medicine that ***“the overall clinical consequences of Covid-19 may ultimately be more akin to those of a severe seasonal influenza.”***⁶

With this as a background, let me point to the following facts:

1. Fauci and other global health authorities have confirmed that the existing COVID vaccines only help reduce the symptoms of the disease, and therefore, they do not prevent a person from getting or spreading the disease.⁷ That is why they continue to recommend persons wear masks even if vaccinated.

2. The COVID vaccines are causing all sorts of injuries in the young and old, from blood clots to heart inflammation, trembling, seizures and death, to name a few. As of April 23, 2021, the CDC's "Vaccine Adverse Event Reporting System" or VAERS, which is used to track COVID vaccine injuries, shows 119,000 reports of adverse events and 3,500 deaths.⁸ According to a Harvard study sponsored by the CDC, less than 1% of adverse events and deaths are actually reported in the VAERS system.⁹ If this is correct, that means that potentially there have been more than 11 million adverse events and 350,000 deaths due to the COVID vaccines.

3. If COVID vaccines don't stop the spread, then they can never help us achieve any sort of herd immunity. This is further proven by the fact that over 10,000 of COVID-vaccinated individuals have contracted COVID after their shots.¹⁰ Therefore, it would make no sense to mandate such vaccine in order to lift restrictions on the unvaccinated population.

4. COVID vaccines have an Absolute risk reduction of around 1%.¹¹ Thus, they are not as effective as claimed by their manufacturers and not worth the risk, as the risks outweigh any benefits.

5. COVID vaccines are issued under an FDA Emergency Use Authorization, and therefore cannot be mandated on anyone.¹² Everyone taking a COVID vaccines is a Guinea Pig in an ongoing medical study. Cal-OSHA's proposed COVID emergency rule results in duress and coercion to force employees to get vaccinated against their will.

6. N-95 masks will not stop a virus from being transmitted to others. If they don't, then ordinary face coverings will be even less effective or worthless.¹³ Not only do medical-grade masks not work,¹⁴ they can actually help the spread of COVID.¹⁵ As Fauci said initially, masks don't work against the COVID virus.¹⁶

7. Masks cause an oxygen deficient hazardous atmosphere and increase the amount of toxic carbon dioxide inhaled by its users.¹⁷ Also, nanomaterial-containing face masks pose a pulmonary threat as they contain biomass graphene,¹⁸ as well as known allergens, carcinogens and controlled substances,¹⁹ especially if worn consistently in an 8-hour work shift day after day. Most masks and face coverings come from China.

8. Fauci admitted in an interview that if PCR tests are run above a cycle threshold of 35 their accuracy is miniscule, giving room for false positives.²⁰ The standard testing cycle threshold for COVID PCR tests used countrywide is 40 cycles, resulting in thousands of false positives. This would explain why we have some many so-called COVID cases, but very few of these with symptoms.

9. Fauci and top officials in the World Health Organization have admitted that asymptomatic carriers of viruses, including COVID, rarely cause the spread of the disease.²¹

10. Continuous disinfecting of working surfaces exposes employees to hazardous chemicals and their fumes. Soap and water are more than enough to kill the COVID virus.²² COVID does not spread easily from touching surfaces.²³

11. Millions of Americans have already contracted COVID and have survived it and now have natural immunity, which is most likely for life, so they should have the same rights as those that are vaccinated, else it will result in discrimination by their employers and Cal-OSHA. And

12. Forcing employers to implement this Cal-OSHA COVID rule is detrimental to businesses and their owners, imposing unnecessary operating expenses in a struggling economy, and will negatively affect the health of their employees. If representatives of Cal-OSHA and this Board reauthorize the COVID rule, they will be in violation of their oath of office, by violating the rights of business owners and unvaccinated employees, including their personal, medical and religious rights not to vaccinate.

Based on all of the above, I respectfully request that this Board immediately rescind the Cal-OSHA COVID order, that it treat the SARS-CoV-2 virus as dangerous as any other seasonal flu, and that it make null and void any citations and fines it issued under the authority of this emergency COVID rule. As an alternative, I request that this Board refrain from making any ruling today until it has reviewed all the data I have referenced herein. Thank you for your consideration.
